Rulemaking/Operations

Since the September 2015 AP meeting:

- Published one proposed rule: ICCAT eBCD
- Published two final rules: Amendment 9 and 2016 shark specifications
- Published multiple inseason actions & oversaw 25 workshops

In 2015:

- Issued 36 EFPs, SRPs, & LOAs
- Issued 7 shark research fishery permits
- Registered 273 HMS tournaments

In 2016, so far:

- Issued 4 EFPs, SRPs, & LOAs
- Issued 5 shark research fishery permits
- Registered 97 HMS tournaments
- ~5,500 people receiving Atlantic HMS News

Amendment 5b Status

- Oceana filed a lawsuit on October 27, 2015 regarding dusky shark management
 - Litigation is ongoing
- Dusky shark stock assessment is underway using data through 2015
 - Peer-reviewed finalized stock assessment is expected by the end of August

- Adjusted Swordfish General Commercial and HMS Charter/Headboat permit (only when on a non-for-hire trip) retention limits

Shark Inseason Actions


2015 Inseason Actions:

- Closed the Gulf of Mexico blacktip, aggregated LCS, and hammerhead shark fisheries on May 3 (80 FR 24836)
- Closed the Atlantic non-blacknose SCS and blacknose shark fisheries on June 7 (80 FR 32040)
- Closed the Gulf of Mexico non-blacknose SCS and blacknose shark fisheries on July 4 (80 FR 38016)
- Closed the Gulf of Mexico non-blacknose SCS fishery on December 5 (80 FR 75436)


2016 Inseason Actions:

- Closed the Gulf of Mexico blacktip, aggregated LCS, and hammerhead shark fisheries on March 12 (81 FR 12602)

Recreational Swordfish Landings





Recreational Billfish Landings





Archival Tag Proposed Rule

Proposed rule expected to publish soon

- Remove the requirement for researchers using internal or external archival tags to obtain written authorization from NMFS and the requirement for fishermen to report their catches of Atlantic HMS with such tags to NMFS
- Keep the regulations allowing fishermen to land any Atlantic HMS in which an archival tag has been surgically implanted, provided such persons return the tag to the research entity indicated on the tag or to NMFS

Request for comment: Should fishermen who catch a fish with an externally attached archival tag, such as a PSAT, be required to release the fish even if the fish is otherwise legal to land?

ESA Updates – Biological Opinions

- On August 27, 2014, NMFS published a final rule to list 20 coral species as threatened under the ESA; 7 of these species are distributed in U.S. Atlantic, Gulf of Mexico, and Caribbean waters
- NMFS reinitiated ESA consultation on these coral species, and the newly listed Western and Central Atlantic DPS of scalloped hammerhead for all HMS fisheries (including pelagic longline fishery for which consultation had already been reinitiated) on October 30, 2014
- Consultation ongoing now for all HMS fisheries

ESA Updates continued – Shark Petitions

- Porbeagle Sharks
 - Full range of populations; Status review underway
- Common Thresher Sharks
 - Positive 90-day finding on a petition to list the species range-wide on 3/3/15; Status review underway
- Smooth Hammerhead and Bigeye Thresher Sharks
 - Positive 90-day finding on a petition to list the species range-wide on 8/11/15 ; Status reviews underway
- Oceanic Whitetip Shark
 - Positive 90-day finding on a petition to list the species range-wide published 1/12/16; Comments closed 3/14/16

Operations/Other

- Continued coordination with Councils & Commissions; ASMFC for sharks
- Louisiana greenstick gear study – *Final report available on request*
- ICCAT monthly submissions: BFT landings, 20m & BET/YFT vessel lists, *quarterly BET landings starting this year*
- ICCAT e-BCD system in progress
- Atlantic HMS Electronic Dealer Reporting system ~active 439 HMS dealers submit all landings data/negative reports weekly; weekly compliance monitoring; monthly shark & swordfish commercial landings reports
- Online Individual Bluefin Quota system has active accounts associated with 241 Atlantic Tuna Longline permits and 436 dealers with tuna permits.

 - Adjustment of 2016 northern albacore quota with 2015 underharvest (up to 25% of the U.S. quota, i.e., ~132 mt, per ICCAT recommendation and if available)
