



Atlantic Swordfish Landings Update: Commercial and Recreational January 1 – January 31, 2012

The table below provides preliminary landings estimates and remaining quotas as of January 31, 2012, in pounds (lb) and metric tons (mt) dressed weight (dw) for the Atlantic swordfish fisheries for the 2012 fishing year. Landings are estimated using commercial dealer reports and reports by anglers in the HMS Non-Tournament Recreational Swordfish and Billfish Landings Database and the Recreational Billfish Survey. Please note that these estimates are subject to late reporting and do not include discards.

The 2012 annual directed landings quota seen below has not been adjusted for 2011 underharvests and does not include the reserve category allocation or international quota transfer. NMFS is currently working on a proposed rule that would adjust the 2012 base quota for these factors and implement other measures based on recommendations from the November 2011 meeting of the International Commission for the Conservation of Atlantic Tunas (ICCAT).

Preliminary commercial and recreational North Atlantic swordfish landings (not including discards) for the 2011 fishing year were 3,743,372 lb dw or 1,698.0 mt dw.
