Data collected on this cruise included the following: acoustic recordings of marine species detected by sonobuoys; oceanographic measurements including water temperature, salinity, dissolved nutrient concentrations, chlorophyll concentrations, zooplankton net and acoustic samples; date, time and location of all sightings of marine mammals and seabirds as well as group characteristics; photographic data for individual identification.

We deployed 24 moorings in the working area (17 passive acoustic, 1 active acoustic, 6 oceanographic). In addition to the mooring and oceanographic work, the vessel will transit to Barrow Canyon and attempted to recover (without success) 3 moorings lost the previous year.

The operating area was within and transiting to and from the Chukchi Sea from Nome, Alaska. Primary mooring locations were perpendicular to the coast, in between the Burger and Klondike oil lease areas. CTD and Tucker tow transects were at five separate locations perpendicular to the coast, extending out for approximately 75 km.
