This database (see <http://www.psmfc.org/rmpc/index.html>) is maintained by the Regional Mark Processing Center (RMPC) of the Pacific States Marine Fisheries Commission (PSMFC) to facilitate exchange of CWT data between release agencies, sampling/recovery agencies, and other data users. NOAA Fisheries at Auke Bay Laboratories (ABL) is responsible for maintaining several different components of this coastwide CWT database including a complete list of release records for CWT salmonids released from Federally-funded research programs in Alaska.
