Daily high and low air temperatures, precipitation, snow fall, snow on the ground, cloud cover, sea surface temperature, surface salinity, Secchi disc depth and water color are taken at the Auke Bay Laboratory. Daily stream temperatures are taken at the Auke Creek Weir. Three meter depth Auke Lake Temperatures are recorded and the Auke Creek Hatchery intake pipe in the lake.
