This dataset includes morphometric data for Alaska phocids (harbor, ribbon, spotted, bearded, ringed seals) that were collected during research trips from 1991-2015. Morphometric data collected during this time period include standard length, curvilinear length, axillary girth, maximum girth, hip girth, mass, and blubber depth. Morphometric data were recorded from measurements made on free-ranging, wild animals, with the exception of the data from 1991. In 1991, the research cruise collected specimens for a scientific collection, so those morphometric data were taken from dead animals.

5.2. Quality control procedures employed (describe or provide URL of description): Morphometric measurements are made by trained individuals who use standard wildlife techniques. Multiple checks on measurements are conducted to confirm data. Data are reported at the highest precision and accuracy possible given the nature of measuring live phocids in often challenging environments and weather conditions. Data forms are reviewed by more than one person before data are finalized and entered into a database. Field data forms are scanned and stored as digital files for reference.
