Samples were collected at California sea lion haulout sites in Washington and from stomach from dead sea lions throughout Washington. Fecal and stomach samples were

cleaned. Prey hard parts were separated using nested sieves, and subsequently identified. Sizes of prey were determined from measurements of fish otoliths and cephalopod beaks using calipers or ocular micrometer. Measurements were used to estimate prey size from published regression equations. Data were entered into a database. Data analyses were performed to address research questions about California sea lion diet.
