Part of The Bering Sea Project, FEAST is a high resolution (~10km<sup>2</sup>) spatial model that uses a Regional Ocean Modeling System for the Bering Sea (ROMS Bering-10K), with two way feedback to a Nutrient-Phytoplankton-Zooplankton Model and two way feedback to a multispecies bioenergetics fish model.
