The survey was designed with two survey tracks, which covered 3,656 nmi2 of the CBS Convention Specific Area. The primary survey track was nearest to the Aleutian Islands and consisted of 35 north-south parallel transects spaced 3 nmi apart and the second survey track was located just north of the primary survey track, and consisted of 12 north-south parallel transects space 9 nmi apart. These second survey track was essentially northern extensions of the primary survey track, designed to observe whether walleye pollock were present in deep er water. The survey followed established AT methods as specified in NOAA protocols for fisheries acoustics surveys and related sampling.
