Echolocation logs (files.FP1) from F-POD echolocation loggers (Chelonia Ltd.) sampled the frequency range of 40 to 160 kHz on a continuous basis from May to September and on a duty cycle of 1 minute every 2 minutes from October to April. Species recorded include harbor porpoise, beluga whales, killer whales, and humpback whales.
