Vessel sensor data are collected electronically using SCS. Station, catch and biological data were collected on paper logs until 2003 when it was collected digitally using the

Fisheries Scientific Computing System (FSCS) V 1.0 data acquisition software. The survey conducted in 2014 utilized an updated version of the FSCS data acquisition system. Data were audited after completion of a survey and prior to being released.

SCS and FSCS data collection software programs employ real-time validation and must meet database integrity constraints. Prior to FSCS data collection, paper logs were pre-audited prior to keypunching. Data were then subject to post-audits.
