NWFSC OA facility water chemistry - Ocean acidification species exposure experimental facility

1.2. Summary description of the data:

We have developed a unique facility for conducting high-quality experiments on marine organisms in seawater with controlled carbon chemistry conditions. The experimental system allows for the dynamic control of pCO₂ and other environmental parameters, which enables us to mimic the natural patterns of variability in carbon chemistry that occur on diurnal and tidal cycles and with upwelling events and phytoplankton blooms. The system also provides control over temperature, dissolved oxygen, food delivery and photoperiod, allowing for experiments on multiple stressors. The relatively high water volumes in the system permit simultaneous experiments on multiple species. The laboratory requires constant uptake to maintain its function and will be modified as needed to support our research program.
