Bankfull elevation is the level at which water begins to leave the channel and move into the floodplain and is reached at a discharge which generally has a recurrence interval of 1 to 2 years on an annual flood series. Critical habitat in estuaries is defined by the perimeter of the water body as displayed on standard 1:24,000 scale topographic maps or the elevation of extreme high water, whichever is greater.Watershed boundaries provide a standard level of detail that is an acceptable unit to describe salmon habitat, and the watershed level 5 (HUC 10s) are nationally recognized by the USGS to spatially relate any dataset that contains these codes.
