Process Steps:

- 2023-04-01 00:00:00 - The data was obtained from the above sources as raw survey data. Please refer to the original source for detailed metadata information on each survey.
- 2023-04-01 00:00:00 - The raw survey data was then processed using an R script, which combined the individual files collected for each regional survey into one dataset with standardized names and units across all regions, and removing unnecessary columns. During this processing step, decisions were made to in some cases trim a region's data to either eliminate certain years or strata based on evaluation of survey coverage for those years or strata.
