- 2023-04-01 00:00:00 The raw survey data was then processed using an R script, which combined the individual files collected for each regional survey into one dataset with standardized names and units across all regions, and removing

unnecessary columns. During this processing step, decisions where made to in some cases trim a regions data to either eliminate certain years or strata based on evaluation of survey coverage for those years or strata.

- 2023-04-01 00:00:00 Process step for Hawaii Island data
- 2023-04-01 00:00:00 The processed data was then fed into a Python script to generate the interpolated biomass distribution maps. These maps were then uploaded to the NOAA Geoplatform as ESRI Imagery mosaic layers for display on DisMAP.
