Under this grant, PIFSC has conducted small boat sampling operations around Oahu to target juvenile eteline snappers, Pacific Islands Fisheries Group fishermen were asked to collect specific sizes of whole fish and bring to LHP staff for processing, and a buyer at the United Fishing Agency (UFA) fish auction was contracted to target large fish and intermediate lengths to fully supplement the field and fisher collections.
