The quality of the data was controlled throughout the data life cycle including data collection, data entry, data cleaning, and data storage. Data were collected following rigid statistical methods (e.g. survey administrators were trained to become familiar with the survey). Data entry files were developed to minimize data entry errors, including setting data ranges, embedding skip patterns, and multiple choice questions were set with predetermined choices. Data were cleaned. Data files were stored in PIFSC's server with password protection.
