1. General Description of Data to be Managed

1.1. Name of the Data, data collection Project, or data-producing Program:

National Coral Reef Monitoring Program: Benthic Images Collected from Climate Stations across the Hawaiian Archipelago since 2013

1.2. Summary description of the data:

Photoquadrat benthic images were collected at NCRMP climate stations and permanent sites identified by the Ocean and Climate Change team across the Hawaiian archipelago since 2013 according to protocols established by the Coral Reef Ecosystem Program (CREP), now known as the Ecosystem Sciences Division (ESD), and the NOAA National Coral Reef Monitoring Program (NCRMP). The imagery allows for a quantitative analysis using image analysis software to derive an estimate of benthic percent cover.

Climate stations are 3-4 sites per island that were selected in a stratified random fashion to be roughly equally spaced around the island, along the 15 m contour, on hard bottom, and at least 1 km away from a river mouth or embayment. Once selected we assess multiple features of the coral reef environment including in-situ temperature (STR), seawater carbonate, net carbonate accretion (CAU), and bioerosion (BMU). In 2013 and 2016, cryptobiota diversity (ARMS) was also assessed.

Lineage Statement:

Benthic photographs were collected for climate stations and permanent sites at pre-defined points along the transect. These photos are color-corrected (if necessary) prior to analysis. The data management team also uses a optical validation script to re-name photos and enforce several validation checks.

Process Steps:

- At the NCRMP climate station a 10m transect is run from the reference stake parallel to shore and in roughly a cardinal (N, S, E, or W) direction. At the 10m mark of the transect tape, a second 5m transect is deployed perpendicular and down-slope. This gives a total of a 15m transect and forms 2 of the boundary sides of the NCRMP plot. Bearings of each transect are recorded. Along the 15m transect tape, two images are taken per meter, for a total of 30 images per climate station.
- Before uploading images for image analysis, ensure there are ~30 images per site and that each of the images correspond to the site. If there are less than 15 images for a site, eliminate the site from image analysis. Additionally, if images are blurry or have poor visibility, exclude them from image analysis. If images are not properly white balanced and/or appear blue, ensure that the images are color corrected utilizing an image editing software before uploading them to the image analysis tool.

Benthic images and the file structure are quality controlled by CREP personnel before they are migrated and integrated into CREP's master optical directory on the PIFSC network.
