(ArcToolbox<Raster<Raster Dataset< Mosaic to New Raster) Parameters included a 32\_BIT\_FLOAT Pixel Type, 1 Band, and a BLEND

- Using the mosaicked 60m resolution bathymetry file, depth contours were created at 40m intervals using ArcToolbox's Contour Tool. (ArcToolbox<Spatial Analyst Tools<Surface<Contour)
- 2019-05-19 00:00:00 The layer's properties were changed to display the unique values for the contours. Applying the Definition Query's Query Builder, the contour polylines were isolated and exported as a shapefile.
- The polyline was incomplete, or unconnected, thus unable to represent a full isobath area at this depth. The Editor tool was used to connect vertices to close the isobath, using hillshade and other contours as guides. (Hillshade was generated using ArcToolbox<Spatial Analyst Tools<Surface<Hillshade)
- The completed polyline was converted to a polygon using Arctoolbox's Feature to Polygon Tool. (ArcToolbox<Data Management Tools<Feature<Feature to Polygon)
