CRCP-Acropora spp. distribution in the upper Florida Keys 2013-2015

### 1.2. Summary description of the data:

This data set is derived from visual surveys by snorkelers using handheld GPS units to map extant live colonies of the threatened corals *Acropora palmata* and *A. cervicornis* in the upper Florida Keys. Appropriate habitat strata were targeted and prioritized from habitat maps in 2005. An initial survey was conducted in 2005-2007 of these reef areas. Follow-up surveys are being conducted in 2013-2015 to assess potential substantial changes in distribution and/or abundance in the same reef areas.

Data collected in situ by snorkelers using handheld GPS units. Data collected as waypoints (items to be mapped, specifically Acropora spp. colonies) and tracks (

signifying the reef area searched). These waypoints and tracks were downloaded via GARMIN software, converted to Excel spreadsheet and then can be imported into GIS for visualization/analyses

Process Steps:

- Data is downloaded from handheld GPS units to a PC and waypoints are associated with individual attributes from field observation sheets. Both these areas can then be uploaded into GIS system.
