The survey was conducted during 2010 between 24 July and 11 August. It was conducted along tracklines oriented perpendicular to the shoreline that were latitudinally spaced 20 km apart aboard a NOAA Twin Otter aircraft at an altitude of 600 feet (183 m) and a speed of 110 knots. The survey was designed for analysis using Distance sampling and a two-team (independent observer) approach to correct for visibility bias in resulting abundance estimates.
