This database contains ichthyoplankton data collected as part of the California Cooperative Oceanic Fisheries Investigations (CalCOFI) program and other cruises that were designed to assess the status coastal pelagic species and the California Current ecosystem from 1951 to present. The primary data are eggs and larvae captured in ring or bongo nets (oblique tows), Calvet or paironet nets (vertical tows), and manta nets (surface tows).
