Process Steps:

- 2005-01-01 00:00:00 - An EASI program was run on the source daily chlorophyll geotifs of the SeaWiFS northeast region to create geotifs for the specified region of the Gulf of Maine. The new geotifs were reprojected from their original SIN E019 projection to Albers Conic Equal Area, NAD 83, GRS 80. These images are scaled down from 16 bit data to 8 bit data. To get the chlorophyll values from the 8 bit geotifs the following formula should be applied to the 8 bit data values: $CHL = 10^{(((8bit \# - 1) * (3/250)) - 1.3)}$
