National Status and Trends: Bioeffects Program - San Francisco Bay Database

1.2. Summary description of the data:

This study was based on the sediment quality triad (SQT) approach. A stratified probabilistic sampling design was utilized to characterize the San Francisco Bay system in terms of chemical contamination, sediment toxicity (Microtox, amphipod bioassays; sea urchin gamete bioassay; and P450 biomarker) and benthic infaunal community structure. The purpose was to define the extent and magnitude of toxicity and other biological effects associated with contaminants in the San Francisco estuary system from the delta to the south Bay and out to the Golden Gate. This file contains data measured in the San Francisco Bay Estuary in 2000 and 2001. Samples were collected for water and sediment analyses.

- Chemicals with similar structural properties were summed and reported as "Totals" in addition to their individual measured concentrations. Infaunal abundance is reported as the total number of individuals per station and the total number of individuals per square meter (= density). Taxa richness is reported as the number of taxa represented in a given site location. Taxa diversity, which is often related to the

ecological stability and environmental "quality" of the benthos, was estimated by the Shannon-Weiner Index (Shannon and Weaver, 1949). In order to quantify and compare the equitability in the fauna to the taxa diversity for a given area, Pielou's Evenness Index J' (Pielou, 1966) was calculated as $J' = H'/\ln S$, where $\ln S = H'_{\max}$, or the maximum possible diversity, when all taxa are represented by the same number of individuals; thus, $J' = H' / H'_{\max}$.
