### 1.1. Name of the Data, data collection Project, or data-producing Program:

Seasonal Composite Raster Images for Sea Surface Temperature in the Gulf of Maine for Stellwagen Bank NMS

### 1.2. Summary description of the data:

This personal geodatabase contains raster images of sea surface temperature (SST) in the Gulf of Maine. These raster images are seasonal composites, and were calculated as means or as medians. The seasons were defined as the following: 1) Fall= September, October, November; 2) Winter= December, January, February; 3) Spring= March, April, May; 4) Summer= June, July, August. For example, June '98, July '98, August '98 = SST Summer '98. These images were also reprocessed to remove land and no data values (value = 252 and value = 0 respectively), as well as to calculate the real world values for sea surface temperature in degrees Celsius (C).

Process Steps:

- 2005-01-01 00:00:00 - CREATING REMOTELY SENSED IMAGES: The global unprojected Pathfinder SST files were received in 4km resolution. They were subset to the US and then assigned proper georeferencing coordinates. The images were reprojected, resampled down to 1.1km resolution, and subset again for the final geotif output currently available. Software used was PCI Geomatica 9.0 and EASI programming. The final Geotif files are 8 bit files.
- 2006-05-01 00:00:00 - REPROCESS REMOTELY SENSED IMAGERY: These remotely sensed images were reprocessed to remove land and no data values as well as to calculate the real world values for sea surface temperature (SST). To do so, a script was written in VB 6.0 and run as a macro in ArcGIS 9.1, which reclassified the land (8 bit value = 252) and no data values (8 bit value = 0) as no data. A second macro also written in VB 6.0 calculated the real world value of sea surface temperature (in degrees Celsius) using the following algorithm:  $SST \text{ (deg C)} = ((8\text{bit}\# * 0.15) + (-3.0))$ . The resulting ERDAS Imagine files were subsequently imported into personal geodatabases.
