Lineage Statement:

This project will investigate the impact of variability in a key nutrient, nitrogen, on lower food webs and the resulting availability of zooplanktonic food resources for Atlantic bluefin tuna larvae in the Gulf of Mexico ecosystem. This information will allow for improvement in Atlantic bluefin tuna stock assessments by making it possible to forecast the feeding, growth, and survival of Atlantic bluefin tuna larvae based on ocean

conditions. To accomplish their objectives, the investigators will determine the sources of nitrogen to the ecosystem and measure plankton biomass and rates of primary productivity. They will also assess the abundance, stomach contents, feeding selectivity, age and growth rates of Atlantic bluefin tuna larvae.
