These data were collected by the National Oceanic Atmospheric Administration National Geodetic Survey Remote Sensing Division using a Riegl VQ820G system. The data were acquired from ""+str(colbdate)+"" - ""+str(coledate)+"". The data includes topobathy data in an LAS 1.2 format file classified as unclassified (1), ground (2), noise (7), water column (25), bathymetric point (26), toppbathy water surface (27), submerged object (29), and International Hydrographic Organization (IHO) S-57 object (30) in accordance with the American Society for Photogrammetry and Remote Sensing (ASPRS) classification standards. This data set may also include lidar intensity values. Not all delivered data contained the classifications listed above instead, please resort to the attribution below.

Process Steps:

- 2013-12-11 00:00:00 - Data were processed to an initial LAS format using the Riegl RiProcess software. The Applanix POSPac software was utilized for GPS and inertial processing, and GeoCuen, Terrasolid, and LP360 software for data visualization, 3D editing, and export to final LAS file. Data were processed in NAD83 horizontal and vertical datum.
- 2015-11-09 00:00:00 - The NOAA Office for Coastal Management (OCM) received the files in las format. The files contained LiDAR elevation and intensity measurements. The data were delivered in UTM Zone 18 (NAD83). The vertical elevations were ellipsoidal in meters referenced to Geoid12b. OCM performed the following processing for data storage and Digital Coast provisioning purposes: 1. The data were converted from UTM Zone 19 (NAD83) coordinates (meters) to geographic coordinates (decimal degrees) and vertical elevation values were left as delivered referenced to the Geoid12b model (meters). 2. Noise classifications were removed for dissemination.
