These data were collected by the National Oceanic Atmospheric Administration National Geodetic Survey Remote Sensing Division using

a Riegl VQ820G system. The data is for Barnegat Light, New Jersey, in Ocean County. The data were acquired from 20130923 - 20130924.

The data includes topobathy data in an LAS 1.2 format file classified as: unclassified (1), ground (2), noise (7), high point (21),

bathymetric point (26), bathy noise (27). For Digital Coast storage purposes, NOAA OCM reclassified the following classes: 21 (high points)

reclassified to 7 (low point, noise), 26 (bathymetric point) reclassified to 11 (NOAA OCM bathymetric lidar point), 27 (bathy noise) reclassified to 9 (water).

Process Steps:

- 2013-12-11 00:00:00 - Data were processed to an initial LAS format using the Riegl RiProcess software. The Applanix POSPac software was utilized for GPS and inertial processing, and GeoCue and Terrasolid software for data visualization, 3D editing, and export to final LAS file. Data were processed in NAD83 horizontal and vertical datum.
- 2014-03-31 00:00:00 - The NOAA Office for Coastal Management (OCM) received the files in las format. The files contained LiDAR elevation and intensity measurements. The data were in UTM Zone 18 (NAD83) coordinates and ellipsoid elevations OCM performed the following processing for data storage and Digital Coast provisioning purposes: 1. The data were converted from UTM Zone 18 (NAD83) coordinates to geographic coordinates. 2. Reclassified the following classes: 21 (high points) reclassified to 7 (low point, noise), 26 (bathymetric point) reclassified to 11 (NOAA OCM bathymetric lidar point), 27 (bathy noise) reclassified to 9 (water). 3. The data were zipped to laz format.
