The original images were acquired at a higher resolution to support the final ortho-rectified mosaic.

- 2017-06-22 00:00:00 - Mosaic's were generated from the color ortho-rectified imagery using Enblend, ExifTool, Imagemagick, Python and GDAL. Mosaic data have not been histogram stretched and only minimal color balancing has been performed. The images are in 8 bit RGB. The DEM source is 30 meter posting USGS

NED. Bilinear resampling method was used to create the final ortho-rectified mosaic. Original image tiles are ~2.5 km by ~2.5 km squares.
