- 2016-11-08 00:00:00 - Mosaic's were generated from the near-infrared ortho-rectified imagery using OrthoVista. Pyramids are built in during this step. Mosaic data have not been histogram stretched and only minimal color balancing has been performed. The images are in 8 bit IR. The DEM source is 30 meter posting USGS

NED. Cubic convolution resampling method was used to create the final orthorectified mosaic. Original image tiles are 2.5 km by 2.5 km squares.
