The source imagery was acquired from 20131023 - 20131024. The images were acquired with an Applinix Digital Sensor System (DSS). The original images were acquired at a higher resolution than the final ortho-rectified mosaic.

Process Steps:

- 2013-12-03 00:00:00 - Mosaic's were generated from the color ortho-rectified imagery using OrthoVista. Pyramids are built in during this step. Mosaic data have not been histogram stretched and only minimal color balancing has been

performed. The images are in 8 bit RGB or IR. The DEM source is 30 meter posting USGS NED. Cubic convolution resampling method was used to create the final ortho-rectified mosaic. Original image tiles are 2.5 km by 2.5 km squares.
