This data set contains ortho-rectified mosaic tiles, created as a product from the NOAA Integrated Ocean and Coastal Mapping (IOCM) initiative of LAKE CHARLES. The source imagery was acquired on November 23, 2009 and March 12, 2010. The true color images were acquired with an Applanix Digital Sensor System (DSS). The original images were acquired at a higher resolution than the final ortho-rectified mosaic.

Process Steps:

- 2010-08-03 00:00:00 - Mosaic's were generated from the color ortho-rectified imagery using OrthoVista. Pyramids are built in during this step. Mosaic data have not been histogram stretched and only minimal color balancing has been performed. The images are in 8 bit RGB. The DEM source is 90 meter posting SRTM

NED. The images were taken from NOAA roll numbers 10NR08, 10NR08, 10NR08 and 10NR08. Cubic convolution resampling method was used to create the final ortho-rectified mosaic. Original image tiles are 2.5 km by 2.5 km squares.
