Process Steps:

- 2017-12-13 00:00:00 - Mosaic's were generated from the near infrared ortho-rectified imagery using OrthoVista. Pyramids are built in during this step. Mosaic data have not been histogram stretched and only minimal near infrared balancing

has been performed. The images are in 8 bit NIR. The DEM source is 30 meter posting USGS NED. Cubic convolution resampling method was used to create the final ortho-rectified mosaic. Original image tiles are 2.5 km by 2.5 km squares.
