Process Steps:

- 2018-11-26 00:00:00 - Mosaic's were generated from the near-infrared ortho-rectified imagery using OrthoVista. Pyramids are built in during this step. Mosaic data have not been histogram stretched and only minimal color balancing has been performed. The images are in 8 bit. The DEM source is 30 meter posting USGS NED.

Cubic convolution resampling method was used to create the final ortho-rectified mosaic. Original image tiles are 2.5 km by 2.5 km squares. All rectified images were loaded in Global Mapper to view the entire project area for tone differences, complete coverage, warping/smearing imagery due to inaccurate DEM, and any other obvious problems. All final tiles are reviewed for artifacts, unblended seam-lines and warps or smears.
