- 2018-12-17 00:00:00 - Mosaic's were generated from the 8 bit ortho-rectified imagery using OrthoVista. Pyramids are built in during this step. Mosaic data have

not been histogram stretched and only minimal color balancing has been performed. The DEM source is 30 meter posting USGS NED. Cubic convolution resampling method was used to create the final ortho-rectified mosaic. Original image tiles are 2.5 km by 2.5 km squares.
