These data provide an accurate high-resolution shoreline compiled from imagery of MANITOU ISLANDS, LAKE MICHIGAN, MICHIGAN . This vector shoreline data is based on an office interpretation of imagery that may be suitable as a geographic information system (GIS) data layer. This metadata describes information for both the line and point shapefiles. The NGS attribution scheme 'Coastal Cartographic Object Attribute Source Table (C-COAST)' was developed to conform the attribution of various sources of shoreline data into one attribution catalog. C-COAST is not a recognized standard, but was influenced by the International Hydrographic Organization's S-57 Object-Attribute standard so the data would be more accurately translated into S-57. - Softcopy compilation was from interpreted imagery based on standard digital photogrammetric procedures. All features were attributed during compilation. The exported shapefile attribution was translated to conform with the NGS 'Coastal Cartographic Object Attribute Source Table (C-COAST)' attribution scheme.
