1. General Description of Data to be Managed

1.1. Name of the Data, data collection Project, or data-producing Program:

Shoreline Data Rescue Project of Afognak and Kodiak Islands, Alaska, PH7017

1.2. Summary description of the data:

These data were automated to provide an accurate high-resolution historical shoreline of Afognak and Kodiak Islands, Alaska suitable as a geographic information system (GIS) data layer. These data are derived from shoreline maps that were produced by the NOAA National Ocean Service including its predecessor agencies which were based on an office interpretation of imagery and/or field survey. The NGS attribution scheme 'Coastal Cartographic Object Attribute Source Table (C-COAST)' was developed to conform the attribution of various sources of shoreline data into one attribution catalog. C-COAST is not a recognized standard, but was influenced by the International Hydrographic Organization's S-57 Object-Attribute standard so the data would be more accurately translated into S-57. Process Steps:

- 2001-03-06 00:00:00 - During the vectorization process, all adjoining shoreline maps in the project are displayed on a computer screen and the shoreline is traced and coded appropriately. Maps within a project generally adjoin and, therefore, there is significant agreement of linework across the borders of the shoreline maps. This results in fewer errors related to the edge-matching process. Polygon labels and attributes are assigned to features containing area so that users may shade the data to determine land, water, or man-made features. All lines were attributed with feature code values which were translated to conform with NGS's Coastal Cartographic Object Attribute Source Table attribution scheme.
