Shoreline Mapping Program of Dry Tortugas, FL, FL1422A-TB-N

1.2. Summary description of the data:

These data provide an accurate high-resolution shoreline compiled from lidar and imagery of Dry Tortugas, FL . This vector shoreline data is based on an office interpretation of imagery that may be suitable as a geographic information system (GIS) data layer. This metadata describes information for both the line and point shapefiles. The NGS attribution scheme 'Coastal Cartographic Object Attribute Source Table (C-COAST)' was developed to conform the attribution of various sources of shoreline data into one attribution catalog. C-COAST is not a recognized standard, but was influenced by the International Hydrographic Organization's S-57 Object-Attribute standard so the data would be more accurately translated into S-57. - 2019-01-30 00:00:00 - The data compilation phase of this project was completed in January 2019 by RSD personnel, and included both automated feature extraction from lidar and manual extraction from orthomosaic imagery. During the automated extraction phase, shoreline vectors were delineated using MHW and MLLW DEMs and a contouring script implemented within Esri's ArcGIS software environment. The orthomosaic image was subsequently used to review, edit, and attribute the lidar shoreline vectors
