### 1.2. Summary description of the data:

These data provide an accurate high-resolution shoreline compiled using lidar and imagery of Marthas Vineyard, MA . This vector shoreline data is based on an office interpretation of imagery that may be suitable as a geographic information system (GIS) data layer. This metadata describes information for both the line and point shapefiles. The NGS attribution scheme 'Coastal Cartographic Object Attribute Source Table (C-COAST)' was developed to conform the attribution of various sources of shoreline data into one attribution catalog. C-COAST is not a recognized standard, but was influenced by the International Hydrographic Organization's S-57 Object-Attribute standard so the data would be more accurately translated into S-57. Process Steps:

- 2019-02-11 00:00:00 - The data compilation phase of the project was initiated by Dewberry personnel in July 2017. Digital mapping was performed with the SOCET for ArcGIS module of SOCET SET. This enabled compilation of features into an Esri Geodatabase where topological and attribution relationships could be enforced. Once compilation was complete, the geodatabase features were exported to shapefile format. Feature attribution was assigned in compliance with the Coastal Cartographic Object Attribute Source Table (C-COAST), which provides the definition and attribution scheme for the full range of cartographic features pertinent to the CMP. Selected features were further modified with additional descriptive information to refine general classification.
