Digital mapping was performed with the SOCET for ArcGIS module of SOCET SET. This enabled compilation of features into an Esri Geodatabase where topological and attribution relationships could be enforced. Once compilation was complete, the geodatabase features were exported to shapefile format. Feature attribution was assigned in compliance with the Coastal Cartographic Object Attribute Source Table (C-COAST), which provides the definition and attribution scheme for the full range of cartographic features pertinent to the CMP. Selected features were further modified with additional descriptive information to refine general classification.
