Shoreline Mapping Program of LITTLE EGG INLET, NJ, NJ1302-TB-N

1.2. Summary description of the data:

These data provide an accurate high-resolution shoreline compiled from lidar and imagery of LITTLE EGG INLET, NJ. This vector shoreline data is based on an office interpretation of imagery that may be suitable as a geographic information system (GIS) data layer. This metadata describes information for both the line and point shapefiles. The NGS attribution scheme 'Coastal Cartographic Object Attribute Source Table (C-COAST)' was developed to conform the attribution of various sources of shoreline data into one attribution catalog. C-COAST is not a recognized standard, but was influenced by the International Hydrographic Organization's S-57 Object-Attribute standard so the data would be more accurately translated into S-57. Process Steps:

- 2015-07-31 00:00:00 - The data compilation phase of this project was completed in June 2015 by RSD personnel and consisted of three different methods. The MHW and MLLW shoreline vectors were delineated using the DEMs discussed above with a Raster-to-Vector script implemented within ESRI ArcGIS 10.1 software. Features which were not significantly elevated above the water level were compiled from the orthomosaics using ArcMap 10.2.2. The remaining elevated features such as bridges, landmarks and navigational aids were compiled directly from the lidar point cloud data within ArcMap 10.2.2 using the LP360 extension. Feature identification and the assignment of cartographic codes were based on image analysis of the project digital orthomosaics and information extracted from the appropriate NOAA Nautical Charts, U.S. Coast Guard Light List and other ancillary sources. Feature attribution was assigned in compliance with the Coastal Cartographic Object Attribute Source Table (C-COAST). Selected features were further modified with additional descriptive information to refine general classification.
