C-COAST is not a recognized standard, but was influenced by the International Hydrographic Organization's S-57 Object-Attribute standard so the data would be more accurately translated into S-57. **Process Steps:** 

- 2018-04-20 00:00:00 - The data compilation phase of project NJ1402C-TB-C was completed by Dewberry personnel in July 2017. NGS supplied the LIDAR derived MHW and MLLW shapefiles to be edited, attributed and generalized. Additional features were then manually compiled using stereo imagery. This work was accomplished using the SOCET for ArcGIS module of BAE's SOCET GXP photogrammetric software. This enabled compilation of features into an Esri Geodatabase where topological and attribution relationships could be enforced. Once compilation was complete, the geodatabase features were exported to shapefile format. Feature attribution was assigned in compliance with the Coastal Cartographic Object Attribute Source Table (CCOAST), which provides the definition and attribution scheme for the full range of cartographic features pertinent to the CMP. Selected features were further modified with additional descriptive information to refine general classification.
