NGS supplied the LIDAR derived MHW and MLLW shapefiles to be edited, attributed and generalized by QSI. Additional features were then manually compiled using stereo imagery. This work was accomplished using a Digital Photogrammetric Workstation (DPW), which consists of a stereo-enabled PC-based graphics workstation running the Windows 2010 operating system and a suite of digital photogrammetric software known as DAT/EM Summit Evolution (version 7.5). Feature identification, segmentation, and attribution were based on imagery analysis of the processed digital images and information extracted from the appropriate NOAA Nautical Charts, the U.S. Coast Guard Light List and other ancillary sources. Feature attribution was assigned in compliance with the Coastal Cartographic Object Attribute Source Table (C-COAST), which provides the definition and attribution scheme for the full range of cartographic features pertinent to the CMP. Selected features were further modified with additional descriptive information to refine general classification.
