- 2018-03-09 00:00:00 - The data compilation phase of project VA1402A-TB-C was completed by Dewberry personnel in December 2016. NGS supplied the LIDAR derived MHW and MLLW shapefiles to be edited, attributed and generalized by Dewberry. Additional features were then manually compiled using stereo imagery. This work was accomplished using a Digital Photogrammetric Workstation (DPW) with the SOCET SET suite of digital photogrammetric software (version 5.6). Feature identification, segmentation, and attribution was accomplished using the SOCET SET Feature Extraction software module, based on imagery analysis of the processed digital images and information extracted from the appropriate NOAA Nautical Charts, the U.S. Coast Guard Light List and other ancillary sources. Feature attribution was assigned in compliance with the Coastal Cartographic Object Attribute Source Table (C-COAST), which provides the definition and attribution scheme for the full range of cartographic features pertinent to the CMP. Selected features were further modified with additional descriptive information to refine general classification.
