The NGS attribution scheme 'Coastal Cartographic Object Attribute Source Table (C-COAST)' was developed to conform the attribution of various sources of shoreline data into one attribution catalog. C-COAST is not a recognized standard, but was influenced by the International Hydrographic Organization's S-57 Object-Attribute standard so the data would be more accurately translated into S-57. - 2002-03-28 00:00:00 - During the vectorization process, all adjoining shoreline maps in the project are displayed on a computer screen and the shoreline is traced and coded appropriately. Maps within a project generally adjoin and, therefore, there is significant agreement of linework across the borders of the shoreline maps. This results in fewer errors related to the edge-matching process. Polygon labels and attributes are assigned to features containing area so that users may shade the data to determine land, water, or man-made features. All lines were attributed with feature code values which were translated to conform with NGS's Coastal Cartographic Object Attribute Source Table attribution scheme.
