Process Steps:

- 2020-08-03 00:00:00 - Individual images were ortho-rectified from POS AV GPS-Aided Inertial Navigation Solution parameters using OSSIM software provided by Radiant Blue. Mosaic data have not been histogram stretched and only minimal color balancing has been performed. The images are in 8 bit RGB. The DEM source is the USGS NED. Original image tiles are 2.5 km by 2.5 km squares.
