- 2005-12-21 00:00:00 - During the vectorization process, all adjoining shoreline maps in the project are displayed on a computer screen and the shoreline is traced and coded appropriately. Maps within a project generally adjoin and, therefore, there is significant agreement of linework across the borders of the shoreline maps. This results in fewer errors related to the edge-matching process. Polygon labels and attributes are assigned to features containing area so that users may shade the data to determine land, water, or man-made features. All lines were attributed with feature code values which were translated to conform with NGS's Coastal Cartographic Object Attribute Source Table attribution scheme.
