### 1.1. Name of the Data, data collection Project, or data-producing Program:

Shoreline Mapping Program of Bodega Bay and Tomales Bay, California, CM-9111

### 1.2. Summary description of the data:

These data were automated to provide an accurate high-resolution composite shoreline of Bodega Bay and Tomales Bay, California suitable as a geographic information system (GIS) data layer. These data are derived from shoreline maps that were produced by the NOAA National Ocean Service including its predecessor agencies. This metadata describes information for both the line and point shapefiles. The NGS's attribution scheme 'Coastal Cartographic Object Attribute Source Table (C-COAST) was developed to conform the attribution of various sources of shoreline data into one attribution catalog. C-COAST is not a recognized standard but was influenced by the International Hydrographic Organization's S-57 Object-Attribute standard so that the data would be more accurately translated into S-57.

Process Steps:

- 2002-01-01 00:00:00 - The Digital Cartographic Feature File was converted into an ESRI(r) shapefile and used as the reference file. During the cleaning process, all adjoining shoreline digital cartographic feature files in the project are combined into one project file. User Added Lines were used to edge-match shoreline that did not connect. All lines were attributed with feature code values which were translated to conform with NGS's Coastal Cartographic Object Attribute Source Table attribution scheme.
