The source imagery was acquired on 20191119 with a Vexcel UltraCam Falcon M2 camera system. The original images were acquired at a 25cm Ground Sample Distance to support the final ortho-rectified mosaic.

- 2020-05-29 00:00:00 - Orthorectified image frames of the four-band imagery were generated using SOCET GXP. Four-band orthomosaics were generated and clipped out to ortho tiles using GeoMedia OrthoPro. Mosaic data have not been histogram stretched. The orthoimage tiles are 1 km by 1 km squares and are 8 bits per band.

Data are projected in NAD83(2011)/UTM 17 North.
