Process Steps:

- 2021-07-09 00:00:00 - Leica XPro software was used to orthorectify the raw Level-0 true color imagery to the DEM using the adjusted position and orientation results from the aerial triangulation phase. The orthorectified strips of imagery, called the Level-2 data, were mosaicked and color balanced, and then clipped out to tiles in uncompressed GeoTIFF format with no overlap. Original image tiles are 3 km by 3 km squares.
